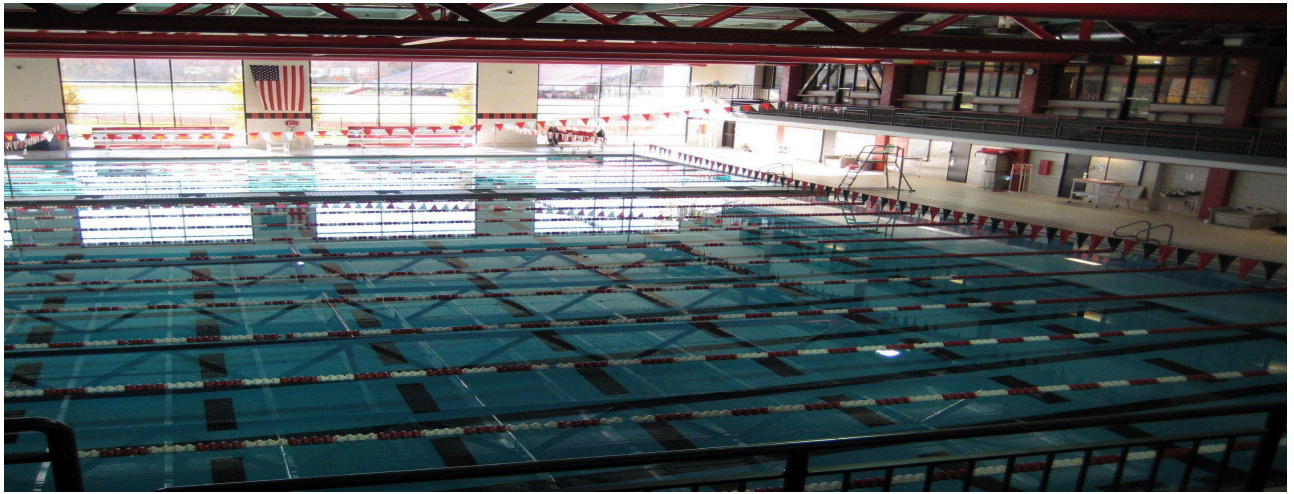
Wednesday September 4th: Outing to Hadleys Candy Shop



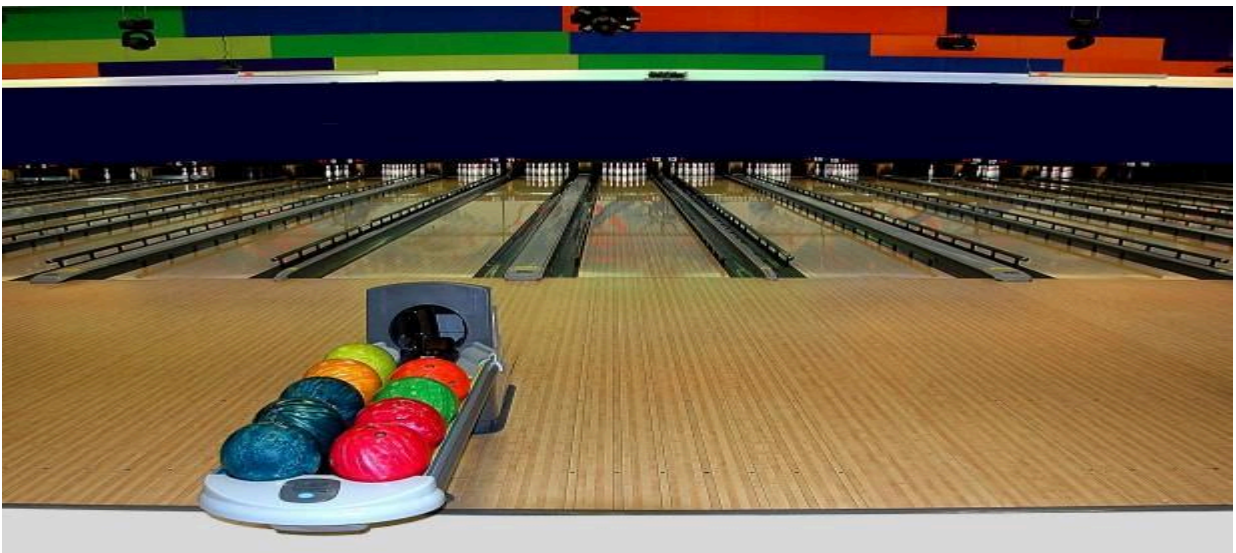
Monday September 9th: Outing to Chins. Consumers will need to bring \$20 for their meal.
